

2002/2003 PROPOSED BUDGET

BUDGET NARRATIVE INFORMATION

Maintenance and Operations on the Levee System - \$335,000

This line item funds crew time, equipment and supplies for carrying out maintenance work on the Pajaro River and emergency work during high winter flows. A summary of the last year's maintenance efforts is attached.

Maintenance Permits (1601/404/0ther) - \$25,000

This line item funds application, processing and related costs associated with various permits required by the Army Corps, Fish & Game, and other agencies in order to conduct Zone 7 maintenance activities.

General Engineering; - \$215,000

Engineering staff time to perform the duties and responsibilities of Zone 7 is funded from this line item.

Management Plan Permit and Environmental Studies - \$25.000

Permit applications for the River Management Plan have been submitted to the County Planning Department as well as State and federal permitting agencies for review and approval. An environmental impact report has been completed and certified.

County Counsel Services - \$20.000

This line item funds County Counsel services associated with ongoing operation of the Zone. These funds are not used to pay for outside counsel assistance with the Pajaro River flood litigation.

Certificate Debt Service - \$421,000

This line item funds debt service on the monies borrowed for the sediment removal, levee resurfacing, and other approved projects.

Levee Sealcoat - \$50,000

All of the recent work to the levees, such as resurfacing, flood fighting efforts, etc., have damaged the existing levee road. In the 1999/2000 fiscal year a significant portion of the levee below state Highway 1 was repaided for safety purposes. It is proposed that additional levee paving be performed downstream of the Salsipuedes Creek confluence on the Pajaro River levees within the City of Watsonville in the 2002/2003 fiscal year.

Flood Control Project Advocacy - \$25,000

This line item funds advocacy efforts in Washington, D.C., Sacramento and within the Army Corps. in support of funding and project authorizations for the Pajaro River levee system reconstruction. This funding also supports consultant participation and advice in the Army Corps process as well as related technical analysis and modeling.

Assessment District Startup - \$40,000

A substantial local cost share will be required in conjunction with the proposed Army Corps River Levee System Reconstruction Project. Many alternate sources for this funding are currently being pursued including additional federal funding, state funding, assistance from upstream and neighboring counties, grant funding and similar options. This line item will fund continued effort in these areas as well as an examination of alternate local options such as assessment district/bond funding.

Pajaro River Watershed Basin Study (FPA funds) - \$11,000

The Pajaro River Watershed Flood Prevention Authority (FPA) was established in July 2000 by Assembly Bill 807 (Keeley). The agency is undertaking studies to determine the impacts of development and land use practices on flooding. Zone 7 is one of eight member agencies. This line item provides funding for required member contribution to the FPA.

Bank Stabilization - \$175.404

The Corps has now completed all remedial work which they plan to carry out. The budget for Bank Stabilization will be used to supplement the Corps' work where appropriate.

Revegetation Proiects - \$135,000

The Army Corps permit conditions for the sediment removal included minimum requirements for bank revegetation. This work will also supplement the Bank Stabilization project with plantings at some of the less serious erosion sites.

<u>Lincoln Street Culvert Replacement - \$90,000</u>

At various locations along the levee, culverts convey stormwater from the Watsonville storm drains to the Pajaro River. This project will replace one such culvert near the end of Lincoln Street.

Army Corps Flood Control Projects \$743,329

District staff has been working with the Army Corps and Monterey County to develop a flood control project to reconstruct the Pajaro River levee system. These funds will be used for necessary local share costs associated with the project.

This district was established to provide funding for implementing proposed Army Corps of Engineers flood control projects on the Pajaro River, Salsipuedes Creek and Corralitos Creek, as well as providing funding for augmented maintenance on these creek/river channels. Staff coordinates with the Corps to ensure local needs are addressed and provides assistance to the Corps as necessary in project evaluation, administrative and engineering drainage services, and is responsible for the replacement, upgrading and maintenance of drainage and flood control facilities in the levee system.

The recommended financing includes an estimated fund balance June 30, 2002 of \$1,025,012, assessments of \$1,255,721, and interest revenue of \$30,000, leaving an estimated \$0 in unappropriated fund balance.

SUBJECT: 2001/02 Zone 7 Annual Maintenance Report

During the 2001/02 fiscal year, various duties including our routine maintenance were completed along the Pajaro River and Salsipuedes Creek in accordance with the Department of Fish and Game Memorandum of Understanding along with emergency storm response work that was necessary. The work performed by our crews **is** summarized both in the following report and in the attached Monthly Report.

The Drainage Division crew, along with two California Department of Forestry crews, cut and cleared all vegetation, which had a three-inch and larger diameter, from the channel slopes on the Santa Cruz County side **of** the Pajaro River & both sides of the Salsipuedes Creek. This clearing was performed between Highway 1 and Murphy's Crossing Road on the Pajaro River and **from** Hwy 152 Bridge downstream to the confluence of the Pajaro River on the Salsipuedes Creek.

Vegetation control on the levee slopes and benches of the Pajaro and Salsipuedes systems **was** completed using both mowing and herbicide application.

Flap gate channels along the Pajaro and Salsipuedes Creek were cleared of silt deposits and vegetation. Necessary repairs were made to the flap gates and culvert pipes. Erosion control repairs were made to flap gate outlet channels and levee slopes on both the Pajaro and Salsipuedes.

Levee road maintenance was performed throughout the system and turn-around spots were created at the Main Street Bridge and at the Hwy 129 Bridge.

During the storm events time was spent monitoring the river and creek water levels, inspecting the levees, clearing logjams and debris, monitoring and maintaining pumps. **This** winter was a fairly mild one **so** there are no major damage sites to repair. Therefore, this year we hope to complete some levee road resurfacing work through Watsonville, between Walker Street and Main Street.

The rodent control program is on going throughout the year along both of the levee systems.

The monthly report is attached for your reference.



Members of the Board:

On March 19,2002, your Board considered a report on the subject plan and considered certification of the Environmental Impact Report (EIR) for the plan. On that date your Board continued consideration of the plan and EIR to April 9,2002. On April 9,2002, your Board received public testimony, adopted California Environmental Quality Act findings and certified the final EIR. Your Board also directed Public Works to pursue required permits for implementation of the plan.

On May 8,2002, the Planning Commission considered and approved costal zone and grading permits and a riparian exception. Subsequent to that approval, two appeals were filed challenging the Planning Commission approval. The appeals were filed by the Sierra Club and the Monterey County Water Resources Agency.

In general terms, the Sierra Club is appealing because they feel that the plan allows too much maintenance work on the river and Monterey County appealed because they believe it allows too little. Copies of both appeals are attached.

On June **4,** 2002, the Board of Supervisors will consider setting a jurisdictional hearing for June 18,2002. At the June 18,2002, hearing, the Board of Supervisors will consider whether to accept or deny jurisdiction of the appeal. If the Board of Supervisors accepts jurisdiction, they must set a hearing date within 30 days of the acceptance of jurisdiction.

Regardless of the outcome of the jurisdictional hearing, Public Works intends to continue the pursuit of permits, taking appropriate actions as a result of the jurisdictional hearings.

It is therefore recommended that your Board accept and file this report **and** direct Public Works to return on September 17,2002, with a further status report.

Dear Chair Beautz and Members of the Board of Supervisors:

This letter will serve to notify the Board of Supervisors of Santa Cruz County that the Monterey County Water Resources Agency appeals the Santa Cruz County Planning Commission's approval and decision to implement: 1) the Pajaro River Management and Restoration Plan on 12 miles of the Pajaro River; 2) the Stream Bank Erosion Assessment Recommendations on 12 miles of the Pajaro River and all of Salsipuedes Creek; and 3) a management plan for the Salsipuedes Creek and 8 miles of Corralitos Creek.

Monterey County Water Resources Agency also appeals the granting of a Coastal Zone Permit, Grading Permit and riparian exception for this project. The project is located on the Pajaro River from the mouth upstream to Murphy's Crossing on Salsipuedes Creek from its confluence with the Pajaro River upstream to College Lake, and on Corralitos Creek from its confluence with Salsipuedes Creek upstream to Browns Valley bridge.

This appeal is based on the following issues:

The above plan and its objectives, if implemented, would adversely affect the environmental, business, property and community interest and uses by Monterey County residents, farmers and business owners along the lower Pajaro River corridor; in particular, the reach of the Pajaro River beginning at Murphy's Crossing and continuing westerly to the mouth of the river. This reach also includes the main stem reach of the Pajaro Levee system, built by the Army Corps of Engineers in 1949. Specifically, the plan is objectionable in that it:

1. would result in an unacceptable and significant restriction and reduction in the flood-carrying and prevention capacity in the area described above;

- 2. relies upon manual vegetation management and maintenance which is ineffective, inefficient and overly costly;
 - 3. puts at risk implementation of a necessary 100-year flood protection plan;
- 4. constitutes environmental discrimination disfavorable to minorities and low income households where families reside and work within the area, and the community of Pajaro;
- 5. will prevent meeting and achieving Federal Emergency Management Agency (FEMA) flood protection standards;
 - 6. will usurp vast portions of agricultural land located within Monterey County;
- 7. exposes Monterey County and related agencies to claims and lawsuits as a result of flooding and associated natural events;
- 8. provides inadequate consideration to necessary river bank maintenance and in- channel maintenance and maximum carrying capacity of the levee system, in particular the Pajaro Levee;
- 9. the Planning Commission decision was based upon deficiencies within the Environmental Impact Report ("EIR") including:
- a) the EIR is deficient in that it is in conflict with the Monterey County General Plan as adopted;
- b) the EIR is deficient in that it does not properly address the impact on low income housing in the community of Pajaro;
- c) the EIR is deficient in that it does not adequately address the current zoning designation of property lying on the Monterey County side of the Pajaro River;
- d) the EIR is deficient in that the proposed Plan is inconsistent with the first listed primary objective of the Plan which is to "maintain the flood carrying capacity of the system." Table 3.8-1, Pajaro River Management and Restoration Plan Alternatives, Alternative-6, Mitigated Alternative, projects a reduction in flood carrying capacity ranging from eight (8) to twenty (20) percent through reaches C through G, as keyed to Figure 2.3-1 Project Area and is silent on the flood reduction impacts for reaches A and B. All other alternatives evaluated have similar adverse impacts to channel capacity. In 1998, existing capacity of the levee system was shown to be insufficient resulting in levee failure. Therefore, no project resulting in diminished capacity can be adequate; and

Dear Board of Supervisors:

This office submits the following Notice of Appeal on behalf of the Santa Cruz Group of the Sierra Club, appealing the decision of the Planning Commission to the Board of Supervisors concerning the approval of the above-referenced project. The Planning Commission approved the above referenced project on Wednesday, May 8, 2002. Thus, this appeal is timely filed pursuant to County Code.

The approval of the above-referenced project violates a number of provisions of the County Code and state law, which include, but are not limited to, the following:

- 1) Approval of the Project in Violation. of Santa Cruz County General Plan Policy 5.2.3 which requires "evidence of approval for development from the U.S. Army Corps of Engineers, California Department of Fish and Game, and other federal or state agencies that may have regulatory authority over activities within riparian comdors and wetlands." This General Plan requirement is much more than a "consultation" requirement. The Planning Commission approved the project with mere consultation of the above referenced agencies. But, in order to grant a riparian exception, these authorities must first grant their approvals.
- 2) Approval of the riparian "exception" was hardly an exception at all. The exception is so sweeping in scope, and provides such vague standards, that the permit allows indiscriminate destruction of riparian resources.
- 3) The proposal violates the California Coastal Act because it allows the destruction of environmentally sensitive habitat areas ("ESHA"), which are protected from development or destruction.
 - 4) Violation of the California Environmental Quality Act because the EIR fails to

adequately provide detailed analysis of vegetation removal, and its mitigations are too vague and uncertain.

- **5)** Violation of the California Environmental Quality Act by failing to perform adequate environmental review pertaining to, but not limited to, cumulative impacts and failing to provide mitigations for identified cumulative impacts; and,
 - 6) Failure to comply with all provisions of the General Plan and the County Code.

For the foregoing reasons, the Planning Commission abused its discretion by failing to proceed in a manner required by law.



On January 15,2002, your Board received the last status report (AttachmentI) on the Pajaro River Watershed Flood Prevention Authority (FPA) and directed that a further report be presented today.

Since the last status report, the FPA Board has met on March 1,2002. A copy of the agenda for this meeting is included as Attachment II. The next FPA Board meeting is scheduled for Friday, May 3,2002, at 9:00 a.m. in the San Benito County Board of Supervisors Chambers in Hollister. Staff of the eight participating agencies (including Zone 7 staff) are continuing to meet monthly to review and develop information for the FPA Board.

The main order of business for the FPA continues to be conducting a Pajaro River Basin Study which will analyze many aspects of basin hyrology and hydraulics including the impact of existing and future development, as well as upstream infrastructure/flood control projects on peak flows in the lower Pajaro River. Raines, Melton and Carella, Inc. (RMC) the contractor selected by the FPA to conduct the study, is on schedule with its analysis and still anticipates completing a Draft Phase I report in May of this year. Once completed, the report and a summary of the key findings will be presented to your Board.

It is also worth noting that the FPA Board previously invited cities within the Pajaro River Watershed, as well as the Pajaro Valley Water Management Agency and Monterey County Redevelopment Agency to join the FPA as Associate (non-voting) Members. To date, the cities of Hollister, Morgan Hill and Gilroy have all appointed representatives.

SUBJECT: PAJARO RIVER WATERSHED STUDY - PHASE I

Members of the Board:

On our agenda today, we will be considering the staff working group's recommendation to accept the subject Phase I study and approve a contract to begin Phase 11. The County of Santa Cruz supports those recommendations, but I would like to provide your Board with some additional information and suggestions in reference to RMC's study that are supported by both Santa Cruz County and the City of Watsonville. This information includes:

- The study identifies the importance of Soap Lake in providing temporary flood storage. This storage tends to attenuate the peak flood flow on the river. It should be documented and understood by all agencies involved that alteration that could result in lessening of storage capacity in the Soap Lake area by development or grading must not be allowed.
- While Soap Lake is very important in providing flood attenuation, there is limited information available to analyze how Soap Lake operates in flood events. Our Board should consider undertaking additional investigation of the Soap Lake Basin in future phases of the Watershed Study.
- One of the four scenarios studied was the impact of the ultimate urban development on peak flood flows. The study concludes that urban development at ultimate build-out would not significantly increase the flood flows for large storm events, such as 100 year events. However, it does indicate that urban development could increase flood flows by almost 8 percent at 25 year flood levels. Given the current flood carrying capacity of the Pajaro River Channel through the Watsonville/Pajaro area, an 8 percent increase would be very significant. Our Board should be aware of this potential significant impact to

downstream communities, especially if an improved levee project is not constructed by the Army Corps of Engineers. This flood impact due to development in the upper basin would need to be mitigated by upstream development detention.

- As previously mentioned, upstream development may or may not impact downstream flood carrying capacity, dependent on the ultimate fate of proposed or future Army Corps Flood Control Projects. Another form of impact that should be considered in future development is encroachment into existing flood plain storage areas, and improvements to other flood control channels in the watershed. Because downstream flooding on the Pajaro River is sensitive to flood timing, development or improvements that alter flood timing or increase channel flow velocities must be evaluated.
- RMC's model is appropriate to use as a design tool for consideration of alternatives for future flood control projects. Our Board may wish to consider additional refinement of the model in future phases to improve its ability to predict basin flood responses.

With consideration given to these issues, the County of Santa Cruz concurs with accepting the Phase I study and moving on to Phase II.

ALTERNATIVE PROPOSAL

Members of the Board:

As your Board knows, on May 8,2002, the Santa Cruz County Planning Commission approved our permit application no. 97-0770, for a mitigated maintenance alternative (no. 6) of the Pajaro River Management and Restoration Plan. One of two appeals of the Planning Commission's approval of our permits was from the Monterey County Water Resource Agency (MCWRA). Amongst various issues cited by Monterey County in their May 22,2002, letter was the concern that manual vegetation management and maintenance is ineffective, inefficient and overly costly. A copy of their letter is included as Attachment 1.

Although we feel that mechanized vegetation clearing (as proposed under alternative no. 8 of the plan) is unlikely to receive permission from the various resource agencies, we are recommending that your Board authorize Zone 7 staff to participate with MCWRA and act as coapplicants for state and federal permits for this alternative. Our understanding is that MCWRA will prepare a supplemental EIR for the Pajaro River Management and Restoration Plan in order to consider this alternative in greater detail and apply for the necessary permits. Zone 7 staff can cooperate with Monterey County staff by sharing and exchanging information developed in support of the staff report to the Santa Cruz County Planning Commission.

MCWRA did not contribute financially toward the existing EIR certified by your Board. As they have appealed the Planning Commission's decision to approve application no. 97-0770, it is appropriate that they now assume a lead role in analyzing and applying for permits leading to some form of mechanized vegetation removal within the project area. As stated earlier, while it does not appear likely that such an alternative will be permitted, we feel it would be prudent to participate in the application.

It is therefore recommended that the Board of Directors take the following action:

- Accept and file this status report.
- Direct Zone 7 staff to cooperate and act as co-applicant with Monterey County to seek permits for alternative no. 8, mechanized vegetation clearing of the Pajaro River.
- 3. Authorize the Director of Public Works to write a letter to the Monterey County Water Resource Agency asking that they take the lead on the development of a supplemental EIR, and the application for permits associated with mechanized vegetation clearing as a possible alternative to the Pajaro River Management and Restoration Plan.



Re: Appeal of Planning Commission's decision of May 8, 2002, Item **H-3**, *APP, No.*, 97-0770 Pajaro River Management and Restoration Plan granting certain Coastal Zone permits, grading permits and riparian exception

Dear Chair Beautz and Members of the Board of Supervisors:

This letter will serve to notify the Board of Supervisors of Santa Cruz County that the Monterey County Water Resources Agency appeals the Santa Cruz County Planning Commission's approval and decision to implement: 1) the Pajaro River Management and Restoration Plan on 12 miles of the Pajaro River; 2) the Stream Bank Erosion Assessment Recommendations on 12 miles of the Pajaro River and all of Salsipuedes Creek; and 3) a management plan for the Salsipuedes Creek and 8 miles of Corralitos Creek.

Monterey County Water Resources Agency also appeals the granting of a Coastal Zone Permit, Grading Permit and riparian exception for this project. The project is located on the Pajaro River from the mouth upstream to Murphy's Crossing on Salsipuedes Creek from its confluence with the Pajaro River upstream to College Lake, and on Corralitos Creek from its confluence with Salsipuedes Creek upstream to Browns Valley bridge.

This appeal is based on the following issues:

The above plan and its objectives, if implemented, would adversely affect the environmental, business, property and community interest and uses by Monterey County residents, farmers and business owners along the lower Pajaro River corridor; in particular, the reach of the Pajaro River beginning at Murphy's Crossing and continuing westerly to the mouth of the river. This reach also includes the main stem reach of the Pajaro Levee system, built by the Army Corps of Engineers in 1949. Specifically, the plan is objectionable in that it:

1. would result in an unacceptable and significant restriction and reduction in the flood-carrying and prevention capacity in the area described above;

- 2. relies upon manual vegetation management and maintenance which is ineffective, inefficient and overly costly;
 - 3. puts at risk implementation of a necessary 100-year flood protection plan;
- 4. constitutes environmental discrimination disfavorable to minorities and low income households where families reside and work within the area, and the community of Pajaro;
- 5. will prevent meeting and achieving Federal Emergency Management Agency (FEMA) flood protection standards;
 - 6. will usurp vast portions of agricultural land located within Monterey County;
- 7. exposes Monterey County and related agencies to claims and lawsuits as a result of flooding and associated natural events:
- 8. provides inadequate consideration to necessary river bank maintenance and in- channel maintenance and maximum carrying capacity of the levee system, in particular the Pajaro Levee;
- 9. the Planning Commission decision was based upon deficiencies within the Environmental Impact Report ("EIR") including:
- a) the EIR is deficient in that it is in conflict with the Monterey County General Plan as adopted;
- b) the EIR is deficient in that it does not properly address the impact on low income housing in the community of Pajaro;
- c) the EIR is deficient in that it does not adequately address the current zoning designation of property lying on the Monterey County side of the Pajaro River;
- d) the EIR is deficient in that the proposed Plan is inconsistent with the first listed primary objective of the Plan which is to "maintain the flood carrying capacity of the system." Table 3.8-1, Pajaro River Management and Restoration Plan Alternatives, Alternative-6, Mitigated Alternative, projects a reduction in flood carrying capacity ranging from eight (8) to twenty (20) percent through reaches C through G, as keyed to Figure 2.3-1 Project Area and is silent on the flood reduction impacts for reaches A and B. All other alternatives evaluated have similar adverse impacts to channel capacity. In 1998, existing capacity of the levee system was shown to be insufficient resulting in levee failure. Therefore, no project resulting in diminished capacity can be adequate; and

e) the EIR is deficient in that the proposed plan violates the Farm Land Preservation Designation as set forth in the Monterey County General Plan.

The Monterey County Water Resources Agency fully supports and remains committed to providing proper flood control maintenance of the Pajaro River. It is because of this commitment that the Agency is concerned that the plan adopted by the Planning Commission is overly restrictive and will seriously hamper the installation and maintenance of future flood control efforts.
