Members of the Board:

On June 4,2002, the Board of Supervisors received three bids for the subject project. All bids were found to be in order. The engineer's estimate was \$180,000. The low bidder was Reber Construction Co., Inc. of Santa Cruz, CA, in the amount of \$219,985.56. Sufficient funds are available in the approved 2001/02 Road Budget to cover this expenditure including contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Reber Construction Co., Inc. in the amount of \$219,985.56 and authorize the award of contract.
- 2. Authorize the Director of Public Works to sign the contract on behalf of the County.
