SUBJECT: RESOLUTION AUTHORIZING SUBMISSION OF APPLICATIONS FOR USED OIL RECYCLING BLOCK GRANTS

Members of the Board:

Since 1995 your Board has supported the Santa Cruz County Regional Oil Recycling Program by approving applications to the California Integrated Waste Management Board (CIWMB) for block grant funds from the California state used oil recycling fund under the Used Oil Recycling Enhancement Act. The Public Works Department has administered the county-wide oil program on behalf of the County and the Cities of Capitola, Santa Cruz, Scotts Valley, and Watsonville. Since 1995, the County and four cities have received over \$755,000 in grant reimbursements from the State.

For grant applications which involve multiple jurisdictions, the CIWMB requires that the lead jurisdiction submit a resolution supporting the submission of the grant application and authorizing the lead agency to administer the grant on behalf of all the named jurisdictions. On January 24, 1995, your Board adopted a resolution which granted such authority into future years. **As** a result of rule changes at the CIWMB, they will now recognize such a multi-year resolution for no more than five years. As your Board's prior resolution on this subject was adopted over seven years ago, a new resolution is required in conjunction with the submittal of the fiscal year 2002/03 Used Oil Block Grant Application. A resolution to this effect is attached for your review.

It is therefore recommended that the Board of Supervisors adopt a resolution authorizing the Director of Public Works to submit regional applications for Used Oil Block Grants to the California Integrated Waste Management Board on behalf of the County of Santa Cruz and the Cities of Capitola, Santa Cruz, Scotts Valley, and Watsonville through June 25,2007.

RESOLUTION APPROVING APPLICATIONS FOR GRANT FUNDS FROM THE USED OIL RECYCLING FUND UNDER THE USED OIL RECYCLING ENHANCEMENT ACT FOR THE SANTA CRUZ COUNTY REGIONAL OIL RECYCLING PROGRAM

WHEREAS, the people of the State of California have enacted the California Oil Recycling Enhancement Act that provides funds to cities and counties for establishing and maintaining local used oil collection programs that encourage recycling or appropriate disposal of used oil; and

WHEREAS, the California Integrated Waste Management Board has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by cities and counties under the program; and

WHEREAS, the applicant for itself and on behalf of the following participating jurisdictions will enter into an agreement with the State of California for implementation of a regional used oil collection program;

NOW, THEREFORE, BE IT RESOLVED that the County of Santa Cruz Board of Supervisors authorizes the submittal of a regional application on behalf of the County of Santa Cruz and the cities of Capitola, Santa Cruz, Scotts Valley, and Watsonville to the California Integrated Waste Management Board for all available Used Oil Recycling Block Grants through June 25,2007.

BE IT FURTHER RESOLVED that the Director of Public Works, or his designee, is hereby authorized and empowered to execute in the name of the participating jurisdictions all necessary applications, contracts, payment requests, agreements and amendments hereto for the purposes of securing grant funds and to implement and carry out the purposes specified in the grant application.
