SUBJECT: ACCEPT UNANTICIPATED REVENUE FOR

THE POLO GROUNDS DOG PARK

Dear Members of the Board:

The County Parks Department is entering the construction phase of the Polo Grounds Dog Park as described in a letter on this agenda from the General Services Department. Last year funds for this project were estimated at \$20,000 to provide a dog park. After investigation, it was determined that the dog park would cost approximately \$27,035 for a fenced dog area, complete with drinking fountain and \$10,000 for other site amenities. Additional funding was still available within the Polo Grounds project since the act project has been delayed until next fiscal year. The recommended bid for construction of this project requires \$31,117 including contingencies which exceeds the funding available within the Polo Grounds project account. Additional funds of \$11,750 are required to complete the funding to award the contract for the Dog Park project and provide for additional site amenities. Funds are available within the Aptos Park Dedication District from unanticipated park dedication fees to complete the funding necessary for this project.

It is therefore RECOMMENDED that your Board adopt the resolution accepting unanticipated revenue from park dedication fees in the amount of \$11,750 within the Aptos Park Dedication District for the additional funding required for the Polo Grounds Dog Park.
