While co-chairing the 1000Local Jobsfor Local People campaign last year, I leamed first hand the value of volunteering my time for the benefit of the community. The goal of this campaign is to find the right fit between employers, the local workforce, and the education community by providing better methods for helping local community members prepare for and find local employment opportunities. Everyone wins in this campaign—local people find local work, local employers find local talent and the education community fully partners in that effort to ensure the right skills are available at the right time. Our Chairing Committee has been particularly interested in ensuring the underrepresented community in the South Bay is prepared for jobs that pay good wages. We are approximately two years through what was envisioned as a five year effort. So far, we are seeing fruits from our investment with so much more to come.

In addition to my experience as the Co-Chair of the 1000Local Jobsfor Local People campaign, I have been in the Human Resources field for over fifteen years, the past six of those years in Santa Cruz. Currently I am Assistant Vice President for Human Resources for Greater Bay Bancorp, which is the holding company for Santa Cruz County's Coast Commercial Bank.

It has been both challenging and a pleasure to be able to find creative solutions to significant local issues. It is a strong interest of mine to continue in that endeavor by working with the Workforce Investment Board. I fully support the goals of the WIB, especially the Well Trained Workforce and Community Vitality goals. We have unique issues in this county with our cost of living, location and type of employment available.
