SUBJECT: 2001/2002 PAVEMENT MANAGEMENT OVERLAY PROJECT

Members of the Board:

The specifications and engineer's estimate for the 2001/2002 Pavement Management Overlay Program are complete and presented here for your consideration and approval. The project provides for resurfacing 21 miles of County-maintained roads through the application of an asphalt pavement overlay. A list of roads with the specific limits is attached.

As your Board may recall, the previously authorized 2001/2002 Pavement Management Program improvements included a \$1,000,000 Asphalt Pavement Digout Project, a \$300,000 Slurry Seal Project scheduled to start in June 2002, and a \$450,000 Chip Seal Project that will be completed by Public Works' road maintenance crews in July 2002. Including the proposed overlay work, a total of more than 60 miles of County roads will have been resurfaced in this second year of the original seven year program. Over its first two years, the funding approved by your Board for the Pavement Management Program has resulted in an overall increase of over 14 percent in the condition of the County road system.


The engineer's estimate for the project is \$4,200,000, not including contingencies and administration. Sufficient funds are available in the 2001/2002 Pavement Management Program to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the specifications, and engineer's estimate and authorize calling for bids for the 2001/2002 Pavement Management Overlay Project.
2. Set the bid opening for 10:45 A.M. on June 25, 2002.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning June 9, 2002, in accordance with the provisions of Public Contract Code Section 20392.
