SUBJECT: LOMOND TERRACE – CSA #28 ROAD IMPROVEMENT PROJECT – PHASE 3 (5th DISTRICT)

Members of the Board:

The plans, specifications and engineer's estimate for the Lomond Terrace **CSA** #28 Road Repair Project, Phase 3 are complete and presented here for your consideration and approval. The project provides for digouts and resurfacing of various locations on Valley View Road, Crossbow Way, Flintlock Lane, Park Drive, and Crest Drive.

The engineer's estimate is \$30,000, not including contingencies and administrative costs. There is sufficient funding in the County Service Area budget.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the specifications and engineer's estimate and authorize calling for bids.
- 2. Set the bid opening for August 27,2002, at 10:45 a.m.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning August 11, 2002, in accordance with the provisions of the Public Contract Code, Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., August 27, 2002 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for a road improvement project for Lomond Terrace CSA #28 in accordance with the specifications therefor, to which special reference is made, as follows:

LOMOND TERRACE CSA #28 ROAD IMPROVEMENT PROJECT, PHASE 3

The work to be done consists, in general, of the reconstruction of portions of the existing roadway through digouts and the application of a 2-inch pavement overlay at the locations indicated on the plan.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
