SEWER AND WATER SERVICE CHARGE REPORT

Members of the Board:

On June 4,2002, your Board adopted ordinances establishing new water and sewer service charge rates for Davenport County Sanitation District and further set today as the public hearing date on the 2002/2003 Sewer and Water Service Charge Report for Davenport County Sanitation District.

In order to complete the 2002/2003 sewer and water service charge rate proceedings, it will be necessary for your Board to now open the public hearing, take testimony, and consider objections and protests, if any, to the Sewer and Water Service Charge Report, and at the conclusion of the public hearing adopt the attached resolution confirming the Sewer and Water Service Charge Report for Davenport County Sanitation District. The Sewer Service Charge Report, containing Assessor's parcel number, use code, owner's name, and the amount of the service charge, was filed with the Clerk of the Board on May 20,2002. As required by law, the Sewer and Water Service Charge Report must be approved by your Board and forwarded to the Auditor/Controller by August 10, 2002.

It is therefore recommended that your Board take the following action:

Open the public hearing, hear objections or protest, if any, to the 2002/2003 Sewer and Water Service Charge Report for Davenport County Sanitation District.

On the motion of Director duly seconded by Director the following resolution is adopted:

RESOLUTION OVERRULING PROTESTS AND CONFIRMING THE REPORT ON WATER AND SEWER SERVICE CHARGES FOR FISCAL YEAR 2002/2003 ON PROPERTY WITHIN THE DAVENPORT COUNTY SANITATION DISTRICT

RESOLVED, by the Board of Directors of the Davenport County Sanitation District, County of Santa Cruz, California, that:

WHEREAS, this Board did, on March 2, 1999, approve Ordinance No. 52, Providing for the Collection of Service Charges on the Tax Roll, and a written service charge report having been filed with the Clerk of said Board containing a description of each parcel of real property and the amount of the service charges to be collected on the County Tax Roll for each parcel of real property receiving services and facilities from the Davenport County Sanitation District for the 2002/2003 fiscal year; and

WHEREAS, this Board appointed the time and place of public hearing on said report and notice was duly given in the manner provided by law as appears by the affidavits of publication on file; and

WHEREAS, said matter came on regularly for hearing at the time and place fixed and all written protests and other communications were publicly read at said meeting and all persons desiring to be heard were fully heard;

NOW, THEREFORE, IT IS DETERMINED AND ORDERED, as follows:

- 1. That objections to and protests against said report were not made by the owners of a majority of the separate parcels of property described in the report.
- 2. That all objections to and protests against said report have been heard by this Board and that said objections and protests be, and each of them is hereby, overruled.
- 3. That said report be, and it is hereby adopted in full with any revision and modification pursuant to Health and Safety Code, Section 5473.3, and that the charges as specified in said revised and modified report shall be collected on the tax roll of the County of Santa Cruz, in the manner provided by law.

4. That the Clerk of the Board is hereby directed to file with the Auditor-Controller of Santa Cruz County, on or before the 10th day of August 2002, a copy of said report, upon which shall be endorsed over the Clerk's signature a statement that the report has been finally adopted by the Board of Directors of the Davenport County Sanitation District, County of Santa Cruz for the 2002/2003 fiscal year.
