SUBJECT: PUBLIC HEARING ON COUNTY SERVICE AREA #11

Dear Members of the Board:

During budget hearings your Board approved the service charges for County Service Area #11 Parks Debt Service. Your Board adopted a resolution establishing the service charge at the same level as previous years and set today as the public hearing date on the 2002/2003 service charge report for CSA#11 Parks Debt Service.

In order to complete the 2002/2003 service charge rate proceedings, it will be necessary for your Board to now open the public hearing, take testimony and consider objections and protests, if any, to the report, and at the conclusion of the public hearing adopt the attached resolution confirming the report. The assessment report, containing the Assessor's parcel number, use code, the owner's name and the amount of the assessment, was filed with the Clerk of the Board since July 19, 2002. As required by law, the service charge report must be approved by your Board and forwarded to the Auditor-Controller by August 10, 2002.


It is therefore RECOMMENDED that the Board of Supervisors take the following actions:
