

SUBJECT: LOMPICO ROAD CULVERT REPLACEMENT PROJECT

Members of the Board:

On August 13,2002, your Board directed the Public Works Department to return on August 20,2002, with project specifications, along with an agreement with the Lompico Water District for the Lompico Road Culvert Replacement Project.

The plans, specifications and engineer's estimate for this project are complete and presented here for your consideration and approval. The project provides for the replacement of existing 36-inch and 48-inch culverts with a 78-inch high by 110-inch wide aluminum pipe-arch culvert, replacing a 24-inch cross culvert adjacent to the project site, repaving the roadway and installation of erosion control mitigation measures.

Also attached for your consideration and approval is a contract with the Lompico Water District. The new culvert installation required that an existing water line be relocated. This relocation is the responsibility of the Lompico Water District; however, in order to avoid construction conflicts and save cost, the water line work has been included in the project specifications. The agreement is to ensure payment from the Lompico Water District prior to award of contract.

The engineer's estimate is \$150,000, not including contingencies and administrative costs. Funding for this project is available in the approved 2002/03 road budget.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the specifications and engineer's estimate and authorize calling for bids.

- 2. Approve the contract with the Lompico Water District **and** authorize the Public Works Director to sign the contract on behalf of the County.
- 3. Set the bid opening for September 17,2002, at 10:45 a.m.
- 4. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning August 25,2002, in accordance with the provisions of the Public Contract Code, Section 20392.



COUNTY OF SANTA CRUZ DEPARTMENT OF PUBLIC WORKS LOMPICO ROAD CULVERT REPLACEMENT PROJECT REIMBURSEMENT AGREEMENT

This Agreement made and entered into this _____ day of______, 2002, by and between COUNTY OF SANTA CRUZ DEPARTMENT OF PUBLIC WORKS, hereinafter referred to as "COUNTY," and the LOMPICO WATER DISTRICT, hereinafter referred to as "LWD";

RECITALS

- A. The COUNTY has plans for a new culvert installation on Lompico Road at PM 2.13. The COUNTY requested that LWD relocate (lower) their waterline to allow for the installation of the new culvert. LWD requested that the COUNTY include the waterline work as a bid item in the culvert project in order to facilitate scheduling efforts, avoid construction conflicts, and save costs.
- B. The COUNTY will solicit bids and award a contract for the project, which will include the waterline relocation work.
- C. The LWD will pay the COUNTY the bid amount for the waterline work prior to the award of contract, plus all related overhead, contingencies, and inspection costs.

NOW, THEREFORE, IT IS AGREED by and between the parties hereto as follows:

- The LWD will provide the COUNTY, plans and specifications for the waterline relocation to be included in the COUNTY'S bid documents for the culvert project.
- 2. The COUNTY will award the project to the lowest responsible bidder irrespective of the proportion of cost relating to the waterline work.
- 3. The COUNTY agrees that all waterline work shall be in conformance with the LWD Standard Specifications and the County's trench repair standards.

- 4. The LWD will pay the COUNTY the dollar amount obtained from the accepted low bid for the waterline work, plus overhead, contingencies, and inspection costs, prior to award of the contract. Additional payment or reimbursement to the LWD may occur when final costs are known at the completion of the project. LWD agrees to pay such additional costs, if incurred through CCO's or extra work within 30 days billing by County.
- 5. Due to permit conditions if this project is to proceed this year, it will be necessary for the County to award the contract within six days following the opening bid. If LWD's payment is not received within that time period (estimated date September 30, 2002), the project could not proceed and all bids
 would therefore be rejected.

This Agreement shall insure to the benefit of and be binding upon the successors and assigns of the parties hereto.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., SEPTEMBER 17,2002** and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on Lompico Road in accordance with the specifications therefor, to which special reference is made, as follows:

LOMPICO ROAD CULVERT REPLACEMENT PROJECT

The work to be done consists, in general, of replacing existing 36" and 48" culverts with an aluminum pipe-arch culvert, replacing a 24" CMP cross culvert, placing compacted backfill, rock slope protection, roadway paving, and erosion control.

Specifications and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410,701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
