On August 18, 1998, your Board approved the reappointment of David W. Moeller as the Agricultural Commissioner/Sealer of Weights and Measures for Santa Cruz County, pursuant to the California Food and Agricultural Code. The Code sets the term of office of the Commissioner at four years from the time of reappointment which in Mr. Moeller's case began September 8, 1998.
