SUBJECT: REDWOOD ROAD STORM DAMAGE REPAIR, PM 0.40

Members of the Board:

At today's Board meeting the Board of Supervisors received two bids for the Redwood Road Storm Damage Repair. All bids were found to be in order. The engineer's estimate was \$157,700. The low bidder was Conley Construction of Santa Cruz in the amount of \$178,090. Funding for the project was included in the approved 2002/2003 Road Budget.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Conley Construction of Santa Cruz in the amount of \$178,090 and authorize the award of contract.
- 2. Authorize the Director of Public Works to sign said contract on behalf of the County of Santa Cruz.
