Dear Members of the Board:

Attached are the resolutions calling for the appointment of unopposed candidates who filed Declarations of Candidacy with the Elections Department for the following districts:

Due to an insufficient number of candidates, the special districts will not appear on the November 5, 2002 ballot.

Pursuant to Elections Code Section 10515, the Board of Supervisors is required to make appointments prior to Monday, December 2, 2002 at a regular or special meeting of the Board. Candidates to be appointed are listed in attached resolutions and on Attachment "A".

Also, pursuant to Elections Code Section 10515 the Board of Supervisors is required to appoint qualified persons to fill vacant positions on the special district boards for which no one filed. The vacancies that need to be filled by November 5, 2002 are:
