All of the groups, Advocacy, Law Enforcement Agencies, Child Witness, Courts, DA and Batterer's are scheduled to review and analyze their respective statistics and submit their sections of the Annual Report to Linda Starn at Dominican Hospital by 2/5/04.

c) Direct Services Report

There is a meeting scheduled for January 15, 2004 from Noon to 1:00 p.m. at the Walnut Avenue Woman's Center. They are in the process of developing a training that conforms with the state mandated batterers intervention program to provide local training to programs who will be providing intervention services to batterers.

The LGBT task force received a grant for \$6,500 to begin evaluating the need for services in the area of domestic violence for the LGBT community.

9. LGBT Task Force

Sonya Drottar announced Women's Crisis Support~Defensa de Mujures has been participating in the Queer Anti-violence Task Force to help them develop resources that address gay domestic violence issues.
