# 5. Oral Communication from the Community

There was no oral communication offered from the community.

6. Impact on recent budgetary constraints upon providers, agencies probation, etc. What are some of the strategies agencies/providers are employing to address the crisis. What can agencies/providers assist each other.

Due to the severe state budget crisis, the impact on services to the community involving domestic violence issues, was discussed. Celia Organista suggested that each agency/provider outline the anticipated impacts to their organization, and submit them to Jeanne Rodriguez so that she can include them with the April agenda.

7. What projects are the organizations/agencies represented on the commission working on. Please share them briefly with the Commission.

Mark Tracy announced that the Sheriff's Office has been awarded an in-custody drug treatment program. This will be an intensive program for individuals housed at the Rountree facility.

Jennifer Rose stated that the Walnut Avenue Women's Shetter has received a grant from the Federal Government that will focus on safety mechanisms for clients.

Kathy Agnone announced that CPVAW sponsored a workshop for eighth grade through high school students addressing women and violence and healthy relationships. Anyone interested in volunteering for future workshops should contact her at CPVAW.

CPVAW will also be sponsoring a self-defense class for Spanish speakers at Holy Cross Church. She asked for suggestions on how to notify the Spanish speaking community about the class.

## 8. ACTION ITEM: Appoint Chair for Direct Services Committee.

Dee O'Brien made a motion that Mary Simoni chair the Direct Services Committee with Alan Hiromura seconding. Motion passed.

# 9. Reports from Committees

## a. South County Family Courts

## b. Attorney General's Survey

Alan Hiromura surveyed all Commissioners who were present on a survey sent from the Attorney General's Office.

#### 1. Evaluation

JoAnn Allen's subcommittee reviewed information from the Probation Department regarding their evaluation process for batterers' treatment. The Probation Department will provide the subcommittee with a list outlining the demographics of the population they serve.

JoAnn circulated a list of questions to Commissioners for a qualitative review of providers.

# 2. Annual Report

Alan Hiromura presented the Commission with preliminary data on batterers programs and law enforcement domestic violence statistics. He notified Commissioners of changes made in the Superior Court--Civil questionnaire. (A copy of the revised questions is attached to these minutes.)

#### 3. D.V. Service Providers

Jennifer Rose reported on a proposed project for the subcommittee. This proposed project is a safety audit in domestic violence cases which is a systematic observation and analysis of the routines within and between agencies, and the paper trails used in processing "cases" of domestic abuse.
