#### 1. Call to Order

#### 5. Oral Communication from the Community

Erica Wood from Applied Survey Research (ASR) spoke to the commission about the project which the commission had written a letter in support of. The Packard Foundation has funded this project which will collect data on children witnessing domestic violence. A letter and work plan was handed out. Organista voiced concern over the commission supporting projects that compete with commission member organizations for limited funds within the same community. McGuire suggested a task force could address the issue raised by Organista. Wood pointed out that ASR's project is about data and not services

## 6. Consideration of Approval of Revised Law Enforcement Protocol

Tracy explained the proposed amendments he and Nickell agreed on . Henri made a motion to approve the revised Law Enforcement Protocol, Allen seconded, motion approved. The revised protocol will be presented to the Chiefs' Association.

# 7. Consideration of Approval of Task Force Procedure (Allen)

Allen presented to the commission the Task Force Procedure for approval. Organista made a motion to approve the form and procedure Starn second, approved.

A discussion was held about the formation and disbanding of existing sub-committees. This will be on the next months agenda for approval. Allen will provide McGuire with the proposal and it will be distributed with the agenda.

Rabow reported that the "annual report group" has not met. Rabow reported the "group" needs to be a sub-committee since the project is longer than six months.

Schneider reported that the "group" which will evaluate domestic violence services did not meet, however, she will distribute information to members of that "group."
