Linda Byrum, who was victimized in a domestic violence case, related her experience in the criminal justice system.

Sheriff Tracy suggested that she make and appointment to speak to him, and District Attorney Bob Lee to discuss specific complaints and possible remedies.

6 Chair Report

Sheriff Tracy announced that Anita Henri has resigned from the Commission. He will be sending her a letter thanking and acknowledging her service to the Commission. He also stated that because of the resignation there is a vacancy for the at-large survivor representative. Applications for appointment to this position may be obtained at the Clerk of the Board of Supervisors office or on the Domestic Violence Commission web site.

7. Reports from Committees

a) Evaluation

Joann Allen reported that the Evaluation Committee has two more batterers treatment programs to review.

b) Annual Report

Alan Hiromura reported that the Report Development/Annual Report Committee will attempt to publish the Annual Report by April 1, 2004. In order to meet that publication date, initial drafts of all of the sections need to be submitted to Dominican Hospital by January 5, 2004. If that deadline is met, Dominican Hospital will submit the final draft for Commissioners to review by February 16, 2004.

The Report Development/Annual Report Committee will meet and develop a more detailed Annual Report schedule and contact the various members of the Domestic Violence Commission to inform them of their responsibilities in the report preparation, and the timelines in which they must complete their sections in order for the Domestic Violence Commission to meet the April 1, 2004, publishing date. The Report Development/Annual Report Committee will coordinate their activities with the Chair of the Commission, Sheriff Tracy.

The Report Development /Annual Report Committee will also work with the Information Services Department to ensure that the Annual Report is placed on the Domestic Violence Commission web site.

Sonya Drottar announced Women's Crisis Support~Defensa de Mujures has been participating in the Queer Anti-violence Task Force to help them develop resources that address gay domestic violence issues.
