# 7. Presentation by Commissioner Stevens

Commissioner Stevens reported that reporting dissatisfaction with the performance of judicial employees was handled with three different procedures.

Judges - Dissatisfaction with a judge's performance of duties should be reported to the Commission on Judicial Performance. Complaints must be in writing and should be mailed to Commission on Judicial Performance, 455 Golden Gate Avenue, Suite 14400, San Francisco, CA 94102.

An informal process is to write a letter to the Presiding Judge.

Bailiff - Dissatisfaction with a bailiff's performance of duties should be reported to the Sheriff.

Other employees of the Court - Dissatisfaction with a employee of the Courts should be report to the Court Administrator on their grievance procedure forms. The Courts will investigate and take appropriate action usually within one week.

C. County Counsel in a written opinion to the Chair McGuire, stated that he believed that the DV Commission needed to amend the DV Commission's ordinance and bylaws if the Commission wanted to have a non-commissioner chair a committee. As a result, there was a motion from Commissioner Allen and a second from Commissioner Harrison to "Amend the DV Commission Ordinance and Bylaws so that a non-commissioner could chair a DV Commission committee. This motion was defeated unanimously.

Commissioners felt that a better alternative was to have all committees be chaired by commissioners and if appropriate appoint a vice chair who was not a commissioner. Although many of the duties of running the meeting could be delegated to the vice chair, the Chair would be responsible to ensure that Brown Act requirements and DV Commission policies and procedures (especially the obligation of financial resources) be adhered to by the subcommittee.

# 9. Report from the Research and Development /Annual Report Committee.

The RD/AR Committee is in the process of creating a survey research instrument that will enable the DV Commission to collect statistics about DV in Santa Cruz County. The goal of this project is to produce an annual report that quantifies the status of domestic violence in our county and provides the DV Commission with statistics to explore with the many agencies involved with domestic violence ways to improve services to the victims of domestic violence as well as batterers and to ultimately reduce domestic violence in Santa Cruz County. To date, the committee has developed questions for law enforcement agencies, the District Attorney, the Courts, Probation, batterers programs and hospitals and clinics.

The committee needs to review victims services, education and miscellaneous information as well as perform a final overall review of the complete survey and develop a form to collect data.

The members of the committee are Commissioner McWhorter, Chair; Commissioner Hiromura, Commissioner Starns, Commissioner Austin, Commissioner Lopez-Molina, Paula Gammell, David Rabow.

# 10. Report from the Evaluation of DV Services Subcommittee

The committee is having difficulty developing a work plan. Commissioner Biggam, Commissioner Organista, Commissioner Henry, Commissioner Allen, Commissioner McGuire, Commissioner Harrison, Julie Schneider, Paula Gammell have agreed to meet

Chair McGuire will ask the DA and law enforcement chiefs in the County to provide DV statistics as they did last October. If they agree, then she will request that the SC Sentinel and Register Pajaronian publish informational boxes as the Sentinel did last year.

Commissioner Raphael recommended that commissoners watch the Frontline special, "Faith and Doubt at Ground Zero".
