SANTA CRUZ COUNTY AGRICULTURAL POLICY ADVISORY COMMISSION November 16, 2017

Recommendations Regarding the Draft EIR on the Proposed Cannabis Cultivation and Manufacturing Ordinances

- 1) The Agricultural Policy Advisory Commission recommends the Board of Supervisors:
 - Remove redundant County Code in the proposed Cannabis Cultivation and Manufacturing Ordinances; and
 - To the greatest extent possible, rely on existing agencies' regulations and enforcement currently in place.
- 2) In order to encourage cultivators and manufacturers to be in compliance with the cannabis cultivation and manufacturing regulations; to maintain economic advantage to the County of Santa Cruz; and, to give cannabis growers and manufacturers the opportunity to plan ahead, the Agricultural Policy Advisory Commission recommends the Board of Supervisors expedite review and processing of cannabis cultivation and manufacturing applications.
- 3) The Agricultural Policy Advisory Commission recommends that the Board of Supervisors adopt the more permissive EIR Alternative 2.
