6. Updates from the Agricultural Commissioner's Office: Entering permit and operator identification number renewal season. Pest detection season has wrapped up without a find of quarantine importance.

7. Updates from the Staff Planner: APAC meetings will continue to take place at the current location until

determined otherwise. The next meeting is scheduled for April 18, but there are no items currently set for that date. The clerk of the Board of Supervisors updated the by-laws to require election officers every April. At the next meeting the chair and vice chair will be appointed. The new by-laws require rotating chairs of the APAC.

Sustainability update: The department has been working for a decade on updating ordinances. On December 5, the Coastal Commission reviewed and commented with amendments which were approved by the Board of Supervisors and will soon go back to the Coastal Commission. The final passing is anticipated in mid-March. We will discuss what effect the updates will have on agriculture in the next meeting.
