Ms. Murphy presented a PowerPoint to the Commission on the status of the property, noting that the property owner will submit future applications to the Commission to remove the property from the Inventory with an updated DPR form, and a second application for interpretive historic information at the site. Ms. Murphy requested that the Commission provide recommendations regarding an appropriate repository for historic materials salvaged from the building. The Commission recommended that the owner approach the Museum of Art and History.

C. Update on the Redman House

Ms. Murphy noted that the fencing surrounding the residence has been in place for several years, and that the owner indicated they currently have no plans regarding the residence. Commissioner Pearlman noted that he had spoken with the Pajaro Valley Historical Association regarding the property. The Commission discussed whether understanding the history of past preservation efforts for this property might help future efforts towards preserving historic resources, and Commissioner Pearlman expressed interest in doing this research.
