GOAL 2 - Inventory Clean-up in three phases/tasks: (1) County staff is proceeding with scanning the existing hard-copy inventory and complete by end of January 2024. Type up new indices. Update the historic resources web page; (2) update county's GIS with DPRs by end of April; (3) update all DPRs to include APN, addresses, owner name, condition of structure – using "continuation sheets". Update DPR photos where necessary and possible. Include permit history (alterations, new construction, etc.). For SFD rated NR-5, exterior alterations only will be update if warranted. Work to be completed fall of 2024.
