Currently Santa Cruz County does not have a Demolition by Neglect ordinance to protect Inventory property. The Commission recommended at the May 2, 2022 meeting that a new ordinance should be created to focus on owners of Inventory listed properties who neglect the preservation of those historic resources.

Commission has discussed proposed parameters for ordinance preventing demolition by neglect. Staff has taken recommendations to update ordinance.
