4. MEETINGS

The Commission shall hold one (1) regular meeting each month. These shall generally fall on the second Thursday of each month and shall commence at 4:30 p.m. Regular meetings may be cancelled as warranted by special circumstances, such as holidays. The Commission may schedule additional meetings as necessary to meet the needs of the Community, the Board of Supervisors or the Commission. Night and/or out-of -building meetings may also be scheduled as the Commission desires. The Commission may also hold special meetings and adjourned regular or adjourned special meetings, as it deems necessary in accordance with state law. Compliance with section 2 of these guidelines is required.
