### 4. REGULAR AGENDA

#### A. Housing Element Update

Erik Schapiro reported that on January 11, 2005 the Board unanimously approved the Revised Housing Element. A program to establish an affordable housing new overlay district was included in the Housing Element approval by the Board. A copy of the Revised Housing Element was sent to the State Department of Housing and Community Development (HCD), and the County is awaiting a response. Commissioners' comments included a question about the suitability of designated sites for higher density development: a comment that consideration be given to the location of overlay sites and that they should more evenly distributed throughout the County: and a comment about where development should occur, in urban or rural areas.

#### B. Update on Measure J Sale and Resale Process

The Commission discussed the Board's recent action concerning the sale or resale of Measure J units, and that after the one-year trial period staff would gather data, re-evaluate the process and report back to the Board. It was requested that staff submit the report to the HAC for review prior to submitting it to the Board.
