Re: Summary of 2019 State Housing Legislation

Each of the major housing-related bills enacted this year is listed below. Click on each bill's number for a link to the California Legislative Information website with complete information about that bill, including analyses prepared by various Legislative staff. The links below go directly to the tab showing "Today's law as amended" which show changes to existing law made by that bill. You may need to scroll down a bit before you see any of the amendments. Blue text shows the insertions made by the bill and red text shows deletions. Black text is the law as it existed prior to enactment of the bill. In most cases these new laws will take effect on January 1, 2020, unless otherwise indicated in the bill language. Staff will provide a presentation on key changes made by these bills that are expected to impact the County during the HAC meeting.
