- 7. Bright in Your Own Backyard (Presentation by Hello Housing) Jennifer Duffy and Rachel McGinis of Hello Housing, a non-profit housing organization, presented findings and best practices related to their "Bright in Your Own Backyard" program, which provides education and technical assistance to homeowners building an ADU or JADU.
- 8. Discussion of ADU Incentive Programs (Attachment III) After some questions, discussion and public comment, the Commission directed staff to prepare a description of a revamped ADU Incentives Program for consideration at its next regular meeting. The new ADU program should retain the fee waiver component, eliminate the loans component, and provide technical assistance. Commissioners suggested seeking up to \$1 million in funding for the program.
- 9. Tiny Home Policy Development (Presentation by Staff and Discussion)

Planner Daisy Allen provided an update on development of draft land use policies to regulate installation of Tiny Homes on Wheels (THOW) on local properties. Commissioners asked questions, provided input, and discussed briefly. Several members of the public also commented.
