Recommend that the Board approve the draft ordinance labeled as Option 1, allowing a THOW to function as a single-family dwelling, as the primary unit, in place of an accessory dwelling unit (ADU), or in place of a junior accessory dwelling unit (JADU); with the following modification specified by the Commission: the tiny home permits should be issued for a five-year term, rather than a three-year term.
