6. Draft 2023 Housing Element: Public Hearing

(Attachment III)

Principal Planners Connolly and Isé provided an overview of the Draft 2023 Housing Element, with the project timeline, community engagement process, sites inventory, including a list of sites proposed for rezoning in the first three years of the 6th Cycle, and remaining milestones before the Draft is submitted to the State. Commissioners asked questions and commented on the presentation. The Chair opened the public hearing on this item at 7:33 pm. Six members of the public commented in person: Ellen Martinez, Dennis Randall, Becky Steinbruner, Tim Willoughby, Elaine Johnson, and Bruce Matesso; and Darius Mohsenin commented via Zoom. The Chair closed the public hearing at approximately 8:05. Following the public hearing and some additional commission deliberation, the Chair called for a motion on this item.

Action: Motion to recommend approval of the Draft 2023 Housing Element as provided in Attachment III, with several additional programs added to pages 63-64 of the 2023 Housing Element, under Goal H3, as follows:

Goal H3: Facilitate the Development of Affordable and Equal Opportunity Housing

Program H-31

In order to encourage additional affordable housing units and provide an incentive for density bonus projects, increase the inclusionary housing requirement for projects of 10 or more units to 20%. For projects seeking a 50% density bonus, the inclusionary requirement should be increased to 25%.

Program H-3J

Because of changes in the housing market regarding the financing of rental projects, making such developments more financially feasible, the inclusionary ordinance shall require the onsite provision of all inclusionary units unless impact fees are approved by the decision-making body as provided in section 17.10.034C.

Program H-3K

Replacement affordable housing units required to replace those demolished as a result of larger new developments shall not be counted toward any inclusionary housing required, but should be in addition to them, so we don't have a net loss of housing.
