### **SUBJECT: Annual Report of the Planning Commission**

Members of the Board:

Transmitted herewith is the annual report of the Santa Cruz County Planning Commission for the 2006 calendar year.

### **Role of the Planning Commission**

The County Planning Commission serves several purposes: 1) Interpretation of the County General Plan; 2) Updating the General Plan; and 3) Consideration of major land use development projects including all land divisions, subdivisions, major commercial developments, rezonings, and General Plan amendments either as the final decision maker or to make a recommendation to the Board of Supervisors. The Commission also acts as the decision maker on appeals of Zoning Administrator Decisions.

### **Meetings**

The Planning Commission meets on the second and fourth Wednesdays of each month at 9:00 a.m. in the Board of Supervisors Chambers, unless otherwise scheduled to avoid conflicts with the use of the chambers. Occasional special meetings are scheduled by the Commission to respond to pressing deadlines or to provide additional opportunity for public participation.

### **Attendance**

Please see the attendance roster included on Page 2. Note that an alternate Commissioner is appointed for each Supervisorial District in the event that the regular Commissioner is unable to attend. On June 20, 2006, Albert Aramburu was appointed to replace Ted Durkee as the Second District Commissioner and on August 22, 2006, Gustavo Gonzalez was appointed to replace Dennis Osmer as the Fourth District Supervisor. He was **previously the** alternate for the Fourth District.

**2006 Activities**

During the year 2006, the Planning Commission conducted 20 public hearings (see attendance roster for dates). Items heard included development applications for five subdivisions, thirteen minor land divisions, and nine requests to zone parcels to Timber Production (TP). The Commission also heard the status of mining permits and permit reviews for one quarry, as well as four appeals of decisions by the Zoning Administrator. The Commission reviewed County policies and made recommendations to the Board of Supervisors. Reviews included the County's Capital Improvement Plan, General Plan, Planning Commission Bylaws, and the Annual Population Growth Goals. The Commission also reviewed proposed ordinance amendments and adopted resolutions regarding the Revised **Housing** Element, recordation of Notice of Historic Resources Designation, Neighborhood Compatibility, adding a very low income affordability component for housing units created by conversions of nonresidential land to residential land, and Conversion of residential units to condominiums or townhouses, The commission also adopted resolutions on four General Plan amendments and rezoning, to amend two Commercial Development permits, and reviewed an amendment to a use permit.
