SUBJECT: REVIEW OF 2019/2020 CAPITAL IMPROVEMENT PROGRAM

Members of the Planning Commission,

The Department of Public Works, in cooperation with the County Administrative Office and the Planning Department, has prepared the Capital Improvement Program (CIP) for the upcoming fiscal year. The annual CIP schedule allows the Planning Commission an opportunity to conduct a study session on the CIP prior to the Board of Supervisors' consideration, pursuant to code 2.74.050(D). Therefore, we herewith submit the 2019/2020 CIP to your Commission.

The document presented for your review identifies proposed capital improvement projects for the 2019/2020 fiscal year and a five-year schedule for making additional improvements to the County's roadway, roadside, flood control, drainage, sanitation, recycling and solid waste, facilities, libraries and park infrastructure. The Executive Summary (Section 1 of the document) provides an overview of the 2019/2020 CIP. In conformance with County Code Section 13.01.130(C), the Planning Department has prepared a memo indicating that their review finds the CIP is consistent with the County General Plan (Exhibit A).

The Proposed 2019/2020 CIP is an outgrowth of many years of effort by the Santa Cruz County community, the Board of Supervisors, and land use and financial agencies of the County to address public service deficiencies identified through public workshops and continuing technical studies and evaluations performed by the County Planning Department and the Department of Public Works, as well as other County agencies.
