11. Community Development and Infrastructure Department Director's Report:

Stephanie Hansen, Assistant Director, noted that the Board of Supervisors approved the short-term rental, Accessory Dwelling Unit (ADU) ordinance, and housing rezones, with all going to the Coastal Commission.

SB 9 approved by Board of Supervisors and going back to Coastal Commission in October.

Housing Advisory Commission considers Condo-ization of ADUs today at 1 pm for consideration of whether to proceed. Eventually it may come to the Planning Commission for consideration, AB1033 allows condo-ization with ordinance adopted by the Board of Supervisors.

Board of Supervisors refused to take jurisdiction on Geri project following Planning Commission upholding conditional approval.

Department and Agency process improvements are on-going with next report back to the Board on October 21.
