I am a resident / property owner on Thurber Lane. The Thurber housing project includes several nice components, especially that 100% of it provides "affordable" rental units. I hope they are truly affordable.

Two of the most important concerns I have are:

- 1. Fire evacuation and access
- 2. Traffic congestion at Thurber and Soquel Dr. (see my ideas please)

Regarding **fire safety:** Please work more closely with the County Fire Department to provide additional safe and quick access to and from Santa Cruz Gardens during a fire or other emergency. Relying on locked gates being opened in time, or cooperation from Chaminade staff is not enough. Not only do residents need to leave, but fire and emergency vehicles and equipment must have quick, dependable access.

Regarding **traffic congestion:** Maybe it is time to permanently open Winkle Avenue as a through route to reduce the bottleneck at Thurber and Soquel Dr? Can a longer right turn lane be added from Thurber onto Soquel Dr.? Aren't emergency vehicles, like ambulances, going to be stuck in traffic backups into and out of Thurber Lane?

I wonder, to **allow space for better neighborhood access** could the parking be put underground to allow more space and move the buildings back to widen Thurber and plant trees?

I dislike some other components of this project, especially it's ugly tenement box appearance, but it is my understanding that we cannot influence such characteristics. Also, the removal of five mature native oaks "... to put in a parking lot....la la la!"
