My name is Glen Novey, owner of 147B Seacliff Drive with access to Glen Drive from my stairway. There is a new proposed project next to my property. It is located at 113 Glen Drive. I believe you have received a blue postcard from the county notifying you of the project and a hearing on it at the Board of Supervisors Chamber at 701 Ocean Street, Room 525 at 9 am on Friday, December 1. I apologize for the late notice but I was trying to get the necessary information.

The proposed fence/wall is very inappropriate for this neighborhood with its ugly chain link and metal construction. I have attached photos. All other fences in the neighborhood are either block or redwood and designed to blend into the environment. Do you think this proposed wall is acceptable in this neighborhood?

The owners of 113 Glen Drive, the Tsangs, are non-residents and don't care about the neighborhood. They have done nothing to repair the house or prevent landslides on the lot above it since there was a mudslide several years ago that knocked out their gas line and the house had to be redtagged. There was another mudslide last winter and a large oak tree fell on their lot. They only very recently had someone re-shingle the roof, after they decided to put it up for sale.
