

We cherish the quietness and open feeling of our home in every direction. We are one of the few that our front yard is not fenced / gated and we frequently have deer in our front yard with their fawn along with bunnies and quail and quite

We love goats and are happy they can be rented annually to clean up areas for Fire control. Most recently goats were rented to clean up the Thurber Lane hillside and also Harbor High school.

We are concerned about the potential noise, the smell of goats, flies, rats and everything else that they may attract. We are concerned about them being an attractive nuisance in the neighborhood attracting more coyotes, mountain lions etc.
