CONTRACTOR SHALL BE RESPONSIBLE FOR PLACING REQUIRED DEPOSITS TO ENSURE TIMELY PROCUREMENT OF THE SPECIFIED PLANTS. CONTRACTOR SHALL PROVIDE COUNTY'S REPRESENTATIVE WITH WRITTEN VERIFICATION (RECEIPTS/CONTRACTS) SHOWING PROCUREMENT TO MEET THE PLANTING REQUIREMENTS. CONTRACTOR MAY, WELL IN ADVANCE OF TIME OF INSTALLATION NEED TO ENGAGE IN CONTRACT WITH GROWERS TO ENSURE PLANT AVAILABILITY.
- 2. THE CONTRACTOR SHALL INSPECT THE PLANTS 6 AND I-MONTH PRIOR TO PLANT DELIVERY DATE TO ENSURE THE QUALITY OF PLANT MATERIALS MEETS OR EXCEEDS THE SPECIFICATIONS.
- 3. HOLD FINISH GRADES FOR PLANTING AREAS I 1/2 INCHES BELOW TOP OF ADJACENT PAVEMENT OR WALLS, UNLESS OTHERWISE NOTED ON THE DRAWINGS.
- 4. GRADUALLY ROUND OFF TOPS AND TOES OF ALL PLANTED SLOPES TO PRODUCE A SMOOTH AND NATURAL TRANSITION BETWEEN EXISTING PLANTINGS, FINISH GRADES AND NEW PLANTINGS.
- 5. ALL EXISTING TREES AND PLANTS SHALL BE PROTECTED IN PLACE UNLESS NOTED OTHERWISE. CONTRACTOR SHALL BE RESPONSIBLE FOR DAMAGE OF ANY KIND TO EXISTING TREES AND PLANTS DURING THE COURSE OF CONSTRUCTION.
- 6. PLACE 2-INCH LAYER OF GRAVEL MULCH IN ALL PLANTING AREAS EXCEPT ON SLOPE, UNLESS OTHERWISE NOTED ON THE DRAWINGS. REFER TO SPECIFICATIONS FOR GRAVEL TYPE.
- 7. PLANT QUANTITIES ARE TO BE BASED ON FIELD OBSERVATION AND NOTED. NEW PLANTINGS ARE INTENDED TO INTEGRATE WITH EXISTING VEGETATION.
